

Article 41. Method of calculating scores for evaluating courses and modules

1. The component assessment scores and final exam scores are graded on a 10-point scale (from 0 to 10), with one decimal place.

2. The course score is the sum of the component assessment scores and the final exam score after calculating the weights specified in the course outline and rounded to one decimal place, then converted to a letter grade.

a) Graded type:

9.0-10 corresponds to A+

8.5-8.9 corresponds to A

8.0-8.4 corresponds to B+

7.0-7.9 corresponds to B

6.5-6.9 corresponds to C+

5.5-6.4 corresponds to C

5.0-5.4 corresponds to D+

4.0-4.9 corresponds to D

b) Ungraded pass type: applies to courses that only require passing, not counted in the average academic score; P: from 5.0 and above.

c) Unsatisfactory type:

Below 4.0 corresponds to F

d) For subjects that do not have sufficient basis to be included in calculating the semester average score, the following symbols are used when assigning assessment levels:

I - Not enough points to evaluate the part

X - No final exam results yet

d) For courses that are allowed by the Head of the training unit to be recognized for credits, transferred scores or evaluated at the beginning of the semester (if any), when assigning the evaluation level, use the symbol R written after the course score.

3. The grading levels A+, A, B+, B, C+, C, D+, D, F are applied to the following cases:

a) Courses for which students have achieved sufficient component assessment scores;

b) Conversion from assessment level I, after having assessment score results the part for which the student was previously allowed by the lecturer to owe;

c) Convert from level X assessment after receiving the final exam results.

4. The F-grade classification, in addition to the cases specified in Clause 2 of this Article, also applies to cases where students violate examination regulations and are determined to receive an F-grade.

5. The classification according to assessment level 1 is applied to the following cases:

- a) During the study period or during the final exam period, if a student is sick or has an accident and cannot take the test or exam, he/she must be permitted by the Head of the training unit;
- b) Students cannot take part in departmental tests or exams for objective reasons and must be approved by the Head of the training unit.

Except for special cases stipulated by the Head of the training unit, in the next semester, students receiving a level I assessment must complete the outstanding departmental examination content to have their scores transferred. In case the student has not paid the debt and has not transferred the score but is not forced to drop out of school, he/she can still continue studying in the next semesters.

6. The classification according to the X assessment level is applied to the courses for which the Training Department has not received the final exam results of the students from the lecturer in charge of the course.

Article 42. Assessment of learning outcomes

Students' learning outcomes are evaluated after each semester according to the following criteria:

- 1. The amount of knowledge learned is the total number of credits of the courses (excluding free elective courses) that the student has registered to study during the semester.
- 2. The accumulated knowledge volume is the total number of credits of courses that have been assessed as passing, calculated from the beginning of the course.
- 3. The semester average is the weighted average of the credits of the courses that the student registers for that semester (including courses that are assessed as passing and failing).
- 4. The average score of all subjects is the average score based on the credit weight of the subjects that the student registered to study from the beginning of the course until the time of review (including subjects assessed as passing and failing).
- 5. The cumulative GPA is the weighted average of the credits of the courses that have been assessed as passing that the student has accumulated, calculated from the beginning of the course until the time of review.
